Subject: Mandatory Recycling Requirements for Sioux Falls Apartments

In an effort to extend the life of the Sioux Falls Regional Sanitary Landfill, the City of Sioux Falls has **mandatory recycling requirements** for waste haulers and Sioux Falls apartment owners.

The recycling requirements asked of licensed waste haulers and Sioux Falls residents is outlined in Chapter 57 of the Code of Ordinances of Sioux Falls, SD.

The City of Sioux Falls endeavors to ensure that all citizens are provided with an opportunity to recycle. Section 57.023 requires every owner of an apartment to provide opportunity and notice of single-stream recycling opportunities to tenants.

A copy of the City's recycling guide is enclosed. This document may be provided to your tenants as recycling education. If you would like to request further assistance with establishing or maintaining a recycling program at your facility, please do not hesitate to contact our office. We would be happy to work with your individual facilities, tenants, and waste haulers to determine a recycling program that would work best for your tenants. Required recyclables include paper products, corrugated cardboard and chip board, plastic bottles, tubs, and jugs, and metal containers such as aluminum and tin cans.
