

**City of Sioux Falls
Statement of Organization
Candidates, Political Action Committee or Ballot Question Committee**

City Ordinance No. 38.006 states the treasurer of a political action committee or a ballot question committee shall file a statement of organization with the city clerk not later than 15 days after the date upon which the committee made contributions, received contributions or paid expenses in excess of \$500 unless the activity falls within 30 days of any municipal election, in which case the statement of organization shall be filed within 48 hours. A candidate shall file a statement of organization for a candidate campaign committee with the city clerk not later than 15 days after becoming a candidate pursuant to § 38.004. Notwithstanding the provisions of § 38.037, the statement of organization shall include the original signature of each person filing the statement. A political committee that regularly files a campaign finance disclosure statement with the secretary of state or another state or the Federal Election Commission or a report of contributions and expenditures with the Internal Revenue Service is exempt from this requirement.




