b. Call for Art

South Dakota artists of all ages and skill levels have been requested to submit original work; painting, drawing, digital art, illustration, or photography for the DTSF Art Box: Outdoor Gallery. Artists will be paid a stipend of up to \$600 for their work. Artwork will be printed on vinyl and wrapped on 1 of 26 utility boxes located around Downtown, Sioux Falls.

c. Jury Guidelines

- The project's goal is to showcase work that represents the entire community.
- Submissions include a written description by the artist of their work. Please review to understand the context of their work.
- Some artists have more than one submission (1A, 1B, 1C). An artist may have more than one piece of artwork selected.
- Some artists have submitted multiple works for one submission. If you like any of the work please select Yes/Maybe and add comments in the NOTES section of the spread sheet.
- One box may have more than one individual artist.
- Group submissions would be the combination of that groups work on one box.
