MEETING MINUTES

ITEM 1. Call to Order & Quorum Determination: Chairperson Joe Schaffer called the meeting to order at 5:30 p.m.

Member Participants: Joe Schaeffer, Jennifer Hoelsing, Kellen Boice, Wyatt Dickson, James Zajicek and Mike Jamison attended the meeting in person. Sara Lum was absent from the meeting (excused)

Other Participants: Diane deKoeyer, Planning and Development Services

ITEM 2. Welcome Members and Guests: No guests were present.

ITEM 3. Approval of the Regular Agenda: Commissioner Dickson made a motion to approve the regular agenda and Commissioner Jamison seconded the motion. The agenda was unanimously approved.

ITEM 4. Approval of the September 15, 2022 Working Session Meeting Minutes: Commissioner Dickson made a motion to approve the meeting minutes and Commissioner Hoelsing seconded the motion. The minutes were unanimously approved.

ITEM 5. Public Input on Non-Agenda Items, Chairperson: No one from the public was in attendance at the meeting to provide input.

ITEM 6. Unfinished Business:

- a) **Future Video with Bronze Age for a bronze pour**
Commissioner Boice reported that Bronze Age has weekly pours and is available to participate in a video with CityLink staff. Commissioner Boice will coordinate with Bronze Age.
- b) **Visibility of the Arts in the Community**
 1. Unveiling of Jake on Base at the Levitt
Bronze Age is in the process (as of 10/25/22) of adding security bolts to the quartzite base and sculpture for security. Once this is complete and the

sculpture is placed at the Levitt, Chair Schaffer can proceed with arrangements for the unveiling.

2. Interviews of Artists from past sculpture submittals

Chair Schaffer said he will be meeting with Cody Henrichs with the Pavilion on Friday and will have more information to report.

3. Sculpture Walk – The VAC should consider if the city should purchase a sculpture from the juried artworks or from the popular vote?

There was discussion on how to proceed and Chair Schaffer suggested inviting Cody Henrichs to the November working session to continue the discussion.

Chair Schaffer also suggested that future artwork chosen from Sculpture Walk should have the artist(s) available for interviews to discuss their work

c) Mural Map Update

The list of additional murals provided by Commissioner Dickson has been photographed. Commissioner Boice suggested also adding the mural at Meldrum Park. Once this is updated Diane will send it to Civic Analytics to include in the mural viewer for public access.
