



# DOWNTOWN SIDEWALK PUB REQUIREMENTS

## SIDEWALK PUB REQUIREMENTS

As per your sidewalk use permit, conditions may be added during its term to address bona fide concerns that arise after issuance. Sidewalk pubs holding a **Retail Liquor License** are required to have stanchions placed at all times unless table service is actively being provided by staff. However, after 10 p.m., stanchions are required for all **Retail Liquor License** holders even if the establishment is offering table service.

Sidewalk pubs holding a **Retail Liquor, Malt, or Wine License** are required to place stanchions during all special events hosted within downtown.

Implementation of stanchions delineating the sidewalk from the furniture zone will enhance the pedestrian experience by ensuring sidewalk activities remain separate from the pedestrian pathway. Delineation of these zones also enhances our Police Department's ability to adequately monitor activity within our downtown during peak times.

When placing stanchions at the respective sidewalk pub, a 36-inch entrance gap is required to comply with ADA standards. It is important to note that stanchions must be removed when the business closes each evening. Stanchions are required to be placed within ten days of this notification.

Appropriate stanchion examples include:



### **POLICE, IF NECESSARY, MAY MONITOR THE FOLLOWING FOR COMPLIANCE:**

- Any time more than 15 people occupy a sidewalk café or sidewalk pub serving alcohol, the pub area shall be staffed so that the area is supervised.
- A maximum ratio of up to one chair per ten square feet shall be allowed in the pub area.
- The designated pedestrian walkway which shall at all times remain free of any intrusion and obstruction.
- Compliance with City noise ordinances shall be deemed a material condition of the limited lease. The City may order the cessation of all noise-generating activities, up to and including closure of the site.

### **ADDITIONAL RULES GOVERNING ALCOHOLIC BEVERAGES IN SIDEWALK PUBS**

- Containers for the dispensing of alcoholic beverages must be maintained inside the licensed facility and not in the furniture zone use area which includes taps, kegs, coolers, or other alcoholic beverage containers.
- Sale and consumption of alcohol in the furniture zone is limited to the area identified in the limited lease.
- All alcoholic beverages served by the permitted establishment must be consumed in the furniture zone or inside the licensed facility and may not leave the licensed premise at any time.
- Patrons and staff loitering with alcohol on the designated pedestrian pathway is a prohibited activity except the transport of alcoholic beverages by patrons or staff directly from the indoor premises to the furniture zone.

### **SIDEWALK PUB SUSPENSION**

In addition to or in lieu of citations, the City may revoke or temporarily suspend a sidewalk pub permit upon finding that any condition set forth in the permit or lease has been violated after investigation and consultation with the leaseholder.
