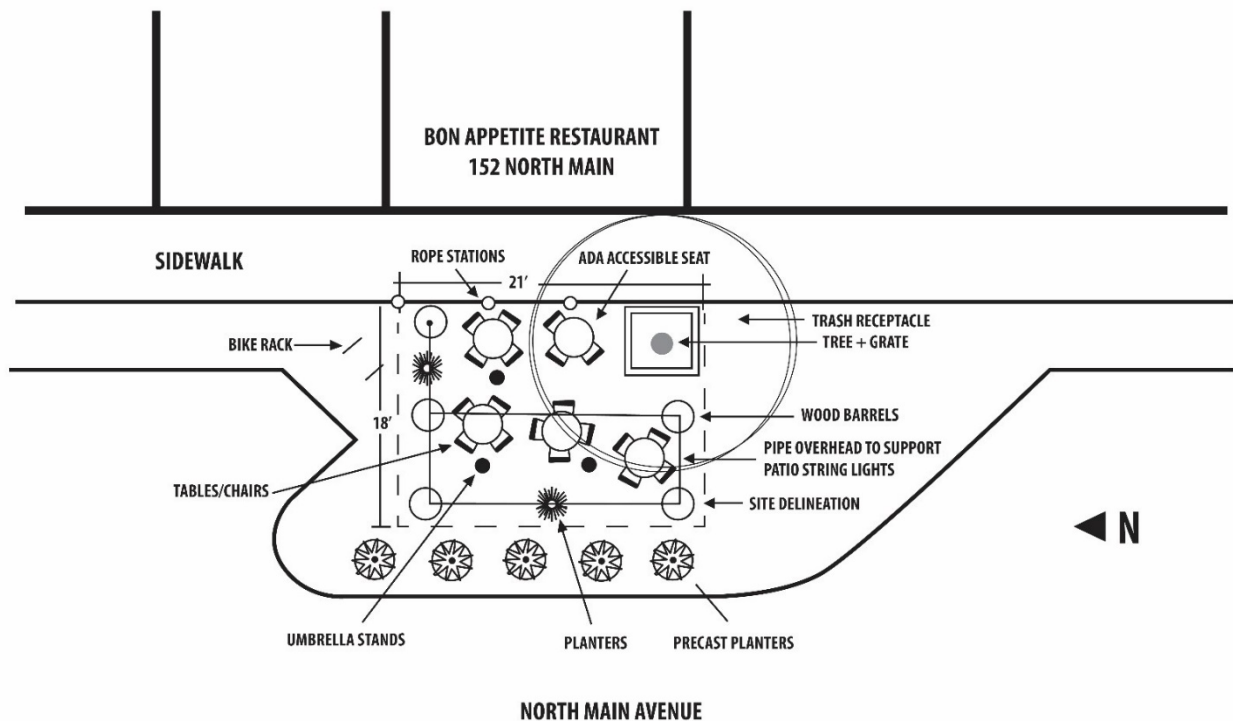

Customary information includes: Tables, chairs with indication of accessible seat(s), planters, menu stands, rope stanchions/bollards, and vending cart. Other items could include heaters, trash receptacles, fire pits, etc. Include dimensions of overall area and size of tables/chairs.

### **Additional required information for application to be complete.**

**The application with all additional requirements is necessary to process the permit or limited lease.**

- Proof of required insurance.
- Peddler's license (if required).
- Crowd Management Plan (if required).
- Additional submissions as required.
- Fire Pit Installation Permit.
- Limited Lease signed by applicant.
- Signed Downtown Sidewalk Pub Requirements document.
