R.F. Pettigrew was one of the first two United States Senators from South Dakota, as well as a member of the House of Representatives. One State historian called him "the foremost citizen of the state." Pettigrew's law practice involved him in many important business and civic matters in Sioux Falls. He resided at two homes in the district.

11:15am: Corson Home

115 N. Duluth Avenue

William Harry Corson built this Queen Anne home in 1886. Harry's younger brother Henry also lived at the home. The Corson brothers built and ran the prosperous Cataract Hotel on the Northwest corner of 9th and Phillips. The home was later owned by the Heinsheimer family; David Heinsheimer was the president and general manager of Home Furniture in Sioux Falls. For about a year in the 1950s, the home operated as a nursing home, and more recently it was divided into four separate apartments. The house is now a single-family home again. The Queen Anne style is characterized by the dominant front porch, asymmetrical floor plan, and the capped tower on the corner of the home.

103 S. Duluth Avenue

Large Queen Anne of two stories. A brick veneer home with bay windows, gable, hipped roof, and stone foundation. Tour Guide: Bob Trzynka, homeowner, Attorney at Halbach Law Firm

11:55am: Marion Bowen Home

840 W. 9th Street

This home is a Gothic Revival gable-and-wing structure that is wood framed with a historic brick veneer. It was veneered with brick between August 1908 and November 1911. It was moved from the corner lot to mid-block in 1908. It has a stone foundation, tall round-arched windows, elaborate gingerbread in the gable ends, and large bay window on the front gable. Since 1976, work on the house has preserved its historic character well. The most visible change from the photographs submitted with that nomination is the railings on the porch and mid-century metal on the steps, to a more compatible square post balustrade.

12:15pm: Effting Grocery & Co.

100 S. Grange Ave.

The Effting Grocery store was constructed in 1908 with exterior materials that included quartzite rubble, sand-lime cement brick and wood windows for exterior materials. In 1981 the sand-lime cement brick was resurfaced with stucco. With removal of the stucco in 2023, moisture had damaged the original, outer wythe of brick that essentially crumbled off the building. New cement brick, matching the original was installed in a matching pattern. The property has been restored to commercial use as a restaurant / office space after being used as residential property for the last 60 years. The owner is in the process of listing the building with the National Park Service.
