

# Water Heater Rebate



## Rebate Checklist

In order to ensure timely approval and issuance of your rebate, please complete the following steps. Incomplete applications may result in delayed payment.

- Read the *application Terms and Conditions* to determine if you are eligible for a rebate under this program
- Complete this application form
- Attach the following documentation:
  - Copy of proof of purchase/sales receipts
  - Verification of lifetime warranty for electric tank water heaters
  - Verification of ENERGY STAR rating AND 10-year warranty for heat pump water heaters
- Submit the application and required documentation to your local utility

**Proof of purchase must be included with this application along with verification of lifetime warranty or ENERGY STAR verification/warranty information for heat pump water heaters.**

## Available Rebates:

- Lifetime warranty electric water heater 50 to 79 gallons: \$200
- Lifetime warranty electric water heater 80 gallons or larger: \$400
- ENERGY STAR rated heat pump water heater: \$400

## Terms & Conditions

The Power Forward water heater rebate program is provided by Heartland Energy in collaboration with the City of Sioux Falls electric utility. Incentives are provided for the purchase of an electric water heater with a lifetime warranty, 50 gallons or larger, OR an ENERGY STAR rated electric heat pump water heater with a minimum 10-year warranty.

- Customers of participating utilities served by Heartland Energy are eligible for rebates.
- Rebates are only available for the purchase of lifetime warranty electric water heaters, 50 gallons or larger, or ENERGY STAR rated heat pump water heaters with a minimum 10-year warranty.
- Eligible water heaters must be purchased and applied for in the current calendar year. Applications must be submitted by December 31, 2024.
- Rebates are available on a first-come, first-served basis and are subject to eligibility and availability of funds. This program is subject to change or termination without notice.
- A copy of proof of purchase/sales receipt and verification of warranty must be included with this application and will not be returned. Water heater must be installed before submitting application.
- Rebates will be issued by your local electric utility in a manner chosen by the utility. Please allow up to 90 days for delivery of rebates.
- Please note: MHD and MR models of Marathon water heaters must now be registered within 90 days of installation to qualify for the Limited Lifetime Warranty. If it is not registered within 90 days, it is covered only by a 10-year Limited Warranty. Proof of registration for these models must be included with this application to qualify for the rebate.
